**PREPAID ELECTRIC SERVICE  
SCHEDULE PE**

**AVAILABILITY**

Available, on a voluntary basis, to Cooperative Customers, subject to the Terms and Conditions of the Cooperative on file with the Virginia State Corporation Commission, and subject to the availability of the necessary automated metering infrastructure at the Customer's location.

**APPLICABILITY**

Applicable, by request of the Customer, to a Customer otherwise served under the Cooperative's Farm and Home Service, Schedule A. Schedule PE is not applicable to Customers using the Cooperative's Schedule NEM-Net Metering, or Budget Billing Program ("EPP"), or who previously terminated service under this rate Schedule PE within the preceding 12 months. Schedule PE is not available at locations where Customers are receiving service subject to a Serious Medical Condition Certification or where the service entrance size is greater than the rating of the Remote Disconnection Device. Customers may not utilize the automatic bank draft payment option.

**DESCRIPTION**

**General** -Upon a Customer's request, the Cooperative will initiate Prepaid Electric Service at the Customer's location, providing a system that is configured to terminate electric service automatically.

**Deposits** -The Cooperative shall not require a Customer utilizing Schedule PE to pay a deposit as a guarantee of payment for services provided by the Cooperative. Deposits previously paid to the Cooperative as a guarantee of payment for services provided shall be returned to a Customer electing to be served under Schedule PE in accordance with the Cooperative's current Terms and Conditions. Any amount to be returned to the Customer may be applied, at the Customer's request, to the amount owed or Prepayment balance.

**Commencing Service** -A Customer seeking service under Schedule PE must establish a minimum Prepayment balance of \$50, prior to receiving service. In addition, if a new service is being established, the Customer must also pay a Service Connection Fee in accordance with the Cooperative's Terms and Conditions Schedule F, Item A.

**Billing, Meter Reading, and Payment for Service** - An Account Calculation will be made after each daily Meter Reading and after each payment is applied to the account. The kWh consumed, as determined by the meter reading, will be multiplied by the kWh rates provided

herein, including the Power Cost Adjustment Rider (Rate Schedule C) and other applicable charges, to determine the cost of the electric service used by the Customer. The cost of electric service used by the Customer, including any Prorated Metering and Billing and Basic Service Charges, other applicable charges, and applicable taxes, will be deducted from the Customer's Prepayments during the Account Calculation. Prorated daily charges will be calculated based upon a 30 day billing cycle and applied. No bills for electric service will be mailed to Customers utilizing Schedule PE. A \$25 minimum payment amount is required for all payment types. Charges will be the same as those for all other Customers on Schedule A, therefore the account will be trued up during a Monthly Billing Cycle process to account for under or over recovery of the daily prorated fixed charges due to a billing cycle of more or less than 30 days.

**Notification of Low Balance** - At the time of enrollment, the Cooperative and the Customer shall agree to the Prepayment balance amount at which a low balance notification will be issued to the Customer. Such amount shall be a reasonable approximation of at least five days of average daily usage at the premises receiving Prepaid Electric Service. If the Cooperative does not have sufficient historical usage information for a customer or premise, the Minimum Notification Level shall be set at \$25 until the Cooperative obtains sufficient usage information to establish a reasonable approximation for five days of average daily usage.

CVEC will provide daily notification to the customer and a third party designated by the customer when the remaining Prepayment balance drops below 5 days estimated average daily electric service usage or \$25 if history is not available to calculate average daily usage. The Cooperative will continue to make daily notifications to the Customer until the Prepayment balance exceeds the predetermined notification level or reaches zero. Once the balance reaches zero or below, the Cooperative will issue a notice that service will be suspended if payment sufficient to re-establish a positive Prepayment balance is not received by 7:00 am of the next business day.

Low balance notification will be provided via automated telephone call, electronic mail, or text message, as selected by the Customer.

**THE CUSTOMER IS RESPONSIBLE FOR MONITORING THE ACCOUNT BALANCE TO ENSURE THAT THE REMAINING PREPAYMENT AMOUNT IS ADEQUATE TO AVOID AUTOMATIC SUSPENSION OF SERVICE.**

**Suspension and Resumption of Electric Distribution Service -**

**WHEN THE COST OF ELECTRIC SERVICE USED EQUALS OR EXCEEDS THE CUSTOMER'S PREPAYMENTS, NOTIFICATION WILL BE PROVIDED THAT THE SERVICE IS SUBJECT TO SUSPENSION. IF A POSITIVE PREPAYMENT BALANCE IS NOT ESTABLISHED BY 7AM THE NEXT BUSINESS DAY ELECTRIC SERVICE WILL BE AUTOMATICALLY SUSPENDED. SERVICE WILL NOT BE SUSPENDED ON WEEKENDS, HOLIDAYS, DAYS SUBJECT TO SEVERE WEATHER RESTRICTIONS, OR OUTSIDE THE BUSINESS HOURS BETWEEN 7 AM AND 3 PM.**

Electric service will automatically resume within three hours when the Cooperative receives payments re-establishing a positive balance. No Fees or Charges shall be applied as the result of Automatic Suspension or Automatic Resumption of electric service. To resume service after 30 days of discontinued service the customer will be assessed a connection charge per Schedule F, Item A of the Terms and Conditions.

#### **TYPE OF SERVICE**

Single-phase, 60 cycles, at available secondary voltages

#### **RATE-BASED ON CVEC's FARM AND HOME SERVICE, RATE SCHEDULE A**

##### **Recurring Charges**

Electric Supply Energy charges are subject to the Power Cost Adjustment Rider as filed under Rate Schedule C.

Applicable taxes will be charged as required by State and Local codes. Any applicable minimum tax will be prorated on a 30 day basis and applied each day of a Monthly Billing Cycle. Any tax calculated on a consumption basis will be applied daily based upon consumption occurring during the billing cycle.

#### **TERM OF CONTRACT**

Service under Schedule PE shall be month-to-month, automatically renewing and continuing from month-to-month, subject to suspension as described herein.
